- 1- A Sign up fee of **\$65.00** will be charged for up to **1000 gallons** a year usage.
A Sign up fee of **\$110.00** will be charged for up to **2000 gallons** a year usage.
A Sign up fee for up to **4000 gallons** a year usage, please **call** for cost.
- 2- Sign up fees and Contracts are non-refundable.
- 3- You will be billed for your Fuel Oil deliveries at our Current Fuel Oil Price, up until that time when our Current Fuel Oil Price goes over the **3.699 net** Price per gallon.
- 4- The billing price will be **3.739 gross** and when the invoice is paid within the **10 day** discount period and the .02/discount for being on automatic, your **net** cost per gallon will be **3.699**. Budget accounts will receive the **.02/per gallons** discount the same as they always do, one total amount at the end of the season.
- 5- You must be on Automatic Delivery and **REMAIN** on automatic delivery for the entire contract period. Going off automatic delivery, automatically voids this agreement. You will always be on Automatic Delivery even after the contract ends, to terminate automatic delivery you **MUST** call or write us to be removed and placed on will call delivery terms. When the contract ends you will remain on Automatic Delivery until you notify Edris Oil that you want your account removed from Automatic Deliveries. Being on automatic delivery can result in summer fills, if you do not want to be filled in the summer, you must notify Edris Oil of this and place your account on a "**Hold Deliveries**" status.
- 6- Any **special / requested deliveries** on or off of the contract, must meet the 150 gallon minimum delivery or account **will be charged a 50.00 Delivery Charge**. Edris Oil will NOT fill cans, barrels, drums or any type of temporary tank / storage container.
- 7- Delinquent accounts will void this agreement.
- 8- Any discounts other than the .02 / 10 day discount and .02 / Automatic delivery discount are Void during the contract period and will resume after contract period is over. (Ex: 1000 tank discount)
- 9- Contract Period runs from **September 1, 2011 to June 30, 2012**. Deliveries before and/or after this period will be billed @ our current daily price per gallon.
